The LLC is published once a week for six consecutive weeks and the costs of publishing vary from county to county, ranging from \$300 to \$2,500. Please note that an LLC will be suspended if it does not comply with Section 206 of the Limited Liability Company Law. A Certificate of Publication must be filed with the Department of State upon completion of the six week advertisement, along with the Affidavits of Publication from each newspaper.
